

## Academic criteria for the recognition of mobility credits

The UIB learning agreement shall specify the subjects and credits that are intended to be taken at the host university, and the UIB subjects for which credit recognition shall be applied for. If the student wishes to change any of the subjects on the learning agreement once at the host university, s/he may do so via the change form. Find more information here.

The criteria below must be met for the recognition of credits from UIB subjects:

- **Total credits**. The number of credits from UIB subjects to be recognised shall not exceed that of the credits taken at the host university.
- Minimum credits. The learning agreement proposal must include a minimum of 18 credits per semester (a full-time semester is considered to consist of 30 credits), 24 credits for the SICUE program (45 credits for the full academic year).
  Agreements that for some justified reason include fewer than the minimum number of credits set in the previous section might be exceptionally accepted, provided that the person in charge of international programmes approves it.
- Core training and passed subjects: Credits shall not be recognised for UIB subjects that the student has already passed or that are listed as core training in the UIB syllabus.
- **Mandatory subjects:** The recognition of credits from mandatory subjects shall only be carried out if:
  - The contents of the subject (or block of subjects) at the host university coincide with those of the UIB subject.
  - The number of credits from the subject (or block of subjects) taken is equal to at least 80% of the credits from the subject to be recognised.

The student will need to provide the teaching guide of the courses to confirm that the two previous conditions are fulfilled.

- **Elective subjects:** The recognition of credits from elective subjects from the UIB syllabus shall be granted provided that the subject taken at the host institution corresponds, to a certain extent, to that of the UIB.
- **General elective credits:** Where the UIB syllabus does not include a subject like the one taken at the host institution, these credits may be recognised as general elective credits.
- **Final Degree Project (TFG):** As a rule, the credits corresponding to the TFG are not recognised for any other subject taken or research work carried out outside the UIB, unless there is a bilateral agreement in place.



- Practical Placements: The recognition of credits corresponding to curricular placements for mobility placements will be governed by the same principles as ordinary placements.
- Language subjects (Double Degrees in Tourism). For the recognition of language subjects, it must be guaranteed that the student will reach at least the same proficiency level that s/he would attain at the UIB, in accordance with the following table of equivalences:

The mobility coordinator and, where applicable, the corresponding tutor shall abide by these criteria to approve the student's learning agreement. Without said approval, the credits from the subjects proposed by the student shall not be recognised.

The subjects taken by the student at the host university and not included in the learning agreement are not part of the exchange programme and, therefore, shall not be subject to academic recognition at the UIB, nor shall they in themselves justify the granting of financial aids for mobility.
